Sub : -Recognition Certificate for the School under Sub-Rule (4) of rule -16 of Right of Children to Free and Compulsory Education Rules(Tripura) ,2011 for the purpose of Section 18 of Right of Children to Free and Compulsory Education Act, 2009.

Dear Sir/Madam ,

With reference to your application date 02-06-2015 and subsequent correspondence with the School / Inspection in this regard. I convey the grant for recognition to the Secretary/Principal , S.F.S. School , Sindukpathar , Satchand ,Sabroom , South Tripura for a period of 3(Three ) years w.e.f 2016 to 2018 Classes- I to VIII (Eight) .

The above sanction is subject to fulfilment of the following conditions : -

1. The grant for recognition is not extendable and does not in any way imply and any obligation to recognize/affiliation beyond Class-VIII.
2. The School shall abide by the provision of right to children to free and compulsory Education Act , 2009(Annexure-I, ) and the right of Children to Free and Compulsory Education Rules,(Tripura), 2011(Annexure-II).
3. The School shall admit in Class-I to the extent of 25% of the strength of that class Children belonging to weaker section and Disadvantage group in the neighbourhood and provide free and compulsory elementary Education till its completion.
4. For the Children referred to in Paragraph 3 the School shall be reimbursed as per Section12(2) of the Act. To receive such Reimbursements School shall provide a separate Bank Account.
5. The Society/School shall not be collect any capitation fee and subject the Child or his/her parents of Guardians to any Screening Procedure.
6. The School shall not deny admission to any Child for lack of age proof. If such admission is sought subsequent to the extended provided prescribed for admission. On the ground of religion , Caste or Race place of birth or any of them.
7. One representative of the School Education Department shall have to be included in the School management committee.
8. The School shall ensure :-
  - i) No child admitted shall held back in any class or expelled from School till the completion of elementary Education in a School.
  - ii) No child shall be subject to Physical punishment or mental harassment.
  - iii) No child is required to pass any Board Examination till the completion of elementary Education.
  - iv) Every child completing elementary education shall be awarded a certificate as laid down under Rule 9.
  - v) Inclusion of students with minimum disabilities/special needs as per provision of the Act.

vi) The teachers are required with minimum qualification as laid under section 23(i) of the Act. Provided further that the current teachers who, at the commencement of this Act. Do not possess minimum qualifications shall acquire such minimum qualifications within period of 5 years.

vii) The teachers performs it duties specified under section 24(i) of the Act. And

viii) The teachers shall not engage himself or herself for private teaching activities.

9. The School shall follow the syllabus on the basis of curriculum laid down by the appropriate authority.

10. The School shall enrol students proportionate to the facilities available in the School as prescribed section 19 of the Act.

11. The School shall maintain the standards and norms of the School as specified in section 19 of the facilities reported at the time of last inspection are as given under.

a) Area of School campus : - 1.7800 hectares,

b) Total built up area : - 800 FT.

c) Area of play ground : - Nil

d) No of classrooms : - 17-nos.

e) Room of Headmaster : - 01-no.

f) Separate toilet for boys and girls : - 10-nos.

g) Drinking water facility : - Available.

h) Kitchen for Mid-Day-Meal : - 2-nos

i) Barrier free Access : -

J) Availability of Teaching learning material /play sports equipments/ library : - Yes.;

12. No unrecognized classes shall run within the premises of the school or outside in the same name of School.

13. The School building or other structure or the ground are not used during the day or night for commercial or residential purpose( except for the purpose of residence of any employee of the School) or for political or non educational activity of any kind whatever.

14. The School is run by a society registered under the societies Registration Act, 1860( 21 of 1860) or a public trust constituted under any law for the time being in force.

15. The School is not run for profit to any individual group or association of individuals or any other persons.




17. The recognition Code number allotted to your school is 062. This may please be noted and quoted for any correspondence with this office.
